## Roles and responsibilities

- Strengthen institutional policies, procedures, and processes that guide the implementation
  of educational technology (EdTech) and distance learning at the university.
- Coordinate the distance learning system and ensure its quality across all academic programs.
- Oversee the governance and administration of distance education in alignment with institutional standards and the Higher Education Council's regulations.
- Contribute to academic functions related to teaching, research, community engagement, and academic administration, as assigned.
- Propose and lead the acquisition of innovative educational technologies and platforms to enhance teaching and learning processes at Zamorano University.
- Design and implement training programs for faculty in collaboration with the Faculty Development Office, focusing on educational technologies and virtual course design methodologies.
- Develop instructional design models for online courses and multimedia educational resources and collaborate with faculty to support adoption and use.
- Guide and monitor the integration of educational technologies, including the design, development, and implementation of virtual and alternative learning modalities.
- Advise and support academic programs and initiatives that incorporate distance education strategies.
- Assist in the development of educational content and materials for projects requiring audiovisual, multimedia, or distance learning components.
- Lead the design and execution of a strategy to promote instructional design and digital learning resources internally and as a service offering to external partners.
- Oversee the production and quality assurance of digital educational materials developed for external projects and clients.
- In collaboration with the IT department, evaluate potential educational technologies and platforms for institutional integration prior to acquisition.
- Manage technological, human, and administrative resources under their purview.
- Supervise and evaluate the performance of team members under their leadership.
- Work closely with the Office of Internationalization to develop partnerships with institutions, government entities, and NGOs to provide consulting, training, and distance learning services aligned with the university's mission.

- Bachelor's degree in Education, Educational Administration, Engineering, Business Administration, or a related field.
- Master's degree in educational technologies or innovation (preferred).
- At least 4 years of professional experience in a related area.
